## GOAL #1

The AAUW MN Public Policy VP will provide information and resources to the branches so that they may better help in informing the public.

## #3 Resolution in Support of the “Minnesota Girls Are Not For Sale” Campaign

### IMPLEMENTATION:

The AAUW Minnesota State Board will work with other likeminded groups such as the Women’s Foundation of Minnesota on the “MN Girls Are Not For Sale” campaign.

The AAUW Minnesota State Board will provide information to its

Branches on resources and ways work together to educate the public through examples like showing the documentary “Miss Representation” which graphically shows the exceedingly poor portrayal of women and girls in the media and gives ideas on how we can work to eliminate this negativity.

## #4 Resolution in Support of Marriage Equality

### IMPLEMENTATION:

The AAUW Minnesota Board will make this resolution known to all branches and encourage branches to avail themselves of ready information in order to examine the issue of same-gender marriage so that members are able to discuss the proposed amendment with others in their communities.

AAUW Minnesota, under the direction of its Board, will become a listed coalition partner of Minnesotans United for All Families as a public declaration of opposition to the amendment.

# Encourage Rather than Discourage Voting

Looking at the current text of Article VII, Section 1 of the Minnesota State Constitution, it is difficult to understand why anyone would want to tamper with the clear-cut guidelines related in this portion of the document. No hazy, out-of-focus qualifications, nothing showing a lack of integrity is apparent in the current wording. I urge you to decide for yourself by examining Article VII, Section 1 of the Minnesota State Constitution.

### Text of Section 1: Eligibility; Place of Voting; Ineligible Persons

Every person 18 years of age or more who has been a citizen of the United States for three months and who has resided in the precinct for 30 days next preceding an election shall be entitled to vote in that precinct. The place of voting by one otherwise qualified who has changed his residence within 30 days preceding the election shall be prescribed by law. The following persons shall not be entitled or permitted to vote at any election in this state: A person not meeting the above requirements; a person who has been convicted of treason or felony, unless restored to civil rights; a person under guardianship, or a person who is insane or not mentally competent. Article VII, Section 1 – Minnesota State Constitution

### The proposed Constitutional amendment would add the following text:

---

*“All voters voting in person must present valid government-issued photographic identification before receiving a ballot. The state must issue photographic identification at no charge to an eligible voter who does not have a form of identification meeting the requirements of this section.”*

---

“Even if the state is required to provide a free voter photo ID to those who don’t have an approved ID, people applying for a ‘free’ voter-photo ID would have to travel to a Department of Vehicle Services office – in some cases 50-100 miles roundtrip – and would be required to show secondary documents, which may cost \$35.” (League of Women Voters)

According to Scott Newman, author of Minnesota’s voter ID amendment, this legislation would “prevent voter fraud and inspire confidence in the integrity of our electoral process.” (Pioneer Press, 06/21/12) [www.twincities.com](http://www.twincities.com)

Our current laws have proven sufficient to deter voter fraud. The penalty can be up to \$10,000 fine and one year in jail. Our system has checks and balances that take place before and after the election to look at everyone who signed the roster to make sure that voter was legitimate. If there are questions, they are forwarded to county attorneys for further investigation

and possible prosecution. Because most of the flagged records are data entry errors or the result of a misunderstanding, charges are rare. Virtually none of these would have been prevented had those voters been required to show photo ID. A photo ID can only prevent voter impersonation. There are no cases of voter impersonation on the record in MN elections.

## Provisional Ballots

No ID at polling place? No problem – simply fill out a provisional ballot. Easy? Not really. Minnesota has never needed provisional balloting because it allows a citizen to register to vote on Election Day and then cast a regular ballot.

How would it work? Under the language of the proposed constitutional amendment, the following could vote only by provisional ballot.

- Any voter who is unable to present an approved form of government-issued photo ID on Election Day.
- Those citizens registering to vote on Election Day (This change in our election system would result from language in the amendment subjecting all voters to “substantially equivalent identity and eligibility verification.” ie. Photo identification)
- Any voter whose identity and/or eligibility is challenged may also have to cast a provisional ballot.

## Cost of Implementing Amendment

To validate a provisional ballot, the voter may have to make at least 3 trips— to a vital records office, to the Department of Motor Vehicles, and then back to the elections office – assuming he or she can get the proper ID in what is likely to be a 3-10 day window.

The costs associated with provisional balloting will fall largely on local governments and likely would be funded through property taxes. (Minnesota has never had the need of provisional ballots in the past.)

Recently Hennepin County released estimates as to what these proposed election law changes would have cost if they had been in effect for the 2008-2010 elections. Hennepin County estimated a cost of \$44,625 for start-up costs associated with provisional balloting. The costs of actually administering the process range between \$142,623 and \$193,150, depending on the year. Source: League of Women Voters MN

## In opposition to the amendment delegates to the Education Minnesota Representative Convention in August 2012 commented:

Educators have a duty to teach their students how to make good choices, and that means weighing the evidence and considering the consequences of every decision. # “Marriage Amendment” – MN Cities Take a Stand

Council voting unanimously to pass a resolution to oppose the equality-limiting marriage amendment on Minnesotans’ ballots this fall.

Cities are making these decisions. You as a voter will be asked to do the same.

## This is what will appear on the ballot November 6, 2012:

Limiting the status of marriage to opposite sex couples.

---

*“Shall the Minnesota Constitution be amended to provide that only a union of one man and one woman shall be valid or recognized as a marriage in Minnesota?”*

---

If passed the Minnesota Constitution would change to include wording that already exists as a Minnesota State Statute. Minnesota has dealt with the issue of marriage between same-sex partners several times over the years. In fact, the Minnesota Supreme Court was one of the first in the nation to rule on the issue of marriage between same-sex couples. The *Baker v. Nelson* decision (291 Minn. 310, 191 N.W.2d 185) in 1971 held that Minnesota Statutes prohibited marriages between same-sex partners.

## Constitutional changes:

The proposed amendment would add a section to *Article XIII* (Miscellaneous Subjects) of the Minnesota Constitution. The section is as follows: *Section 13*. Only

a union of one man and one woman shall be valid or recognized as a marriage in Minnesota.

## Cities Leading with Registration of Domestic Partners

While Minnesota law currently restricts marriage to different-sex couples, state law also allows local governments to register domestic partners (see Ch. 145C). Each of the domestic-partner registration ordinances in Minnesota provides for recognition of registrations from other cities, as well as domestic partnerships, civil unions, and even marriages from other jurisdictions — as municipal domestic partnerships, and nothing more.

## Currently 18 cities/towns in Minnesota have domestic partnership ordinances.

In 1991, the City of Minneapolis created Minnesota’s first municipal domestic-partner registration ordinance. 18 Minnesota cities currently have domestic partnership ordinances that allow (same-sex or opposite-sex) couples who meet certain criteria, but who may not be able marry under state law, the ability to document their relationships for the purpose of securing **voluntary** employer benefits and some limited forms of legal recognition to protect their families. **Those cities are:** Crystal, Duluth, Eagan, Eden Prairie, Edina, Falcon Heights, Golden Valley, Hopkins, Maplewood, Minneapolis, Northfield, Red Wing, Richfield, Robbinsdale, Rochester, Saint Louis Park, Saint Paul, Shoreview, and Shorewood.

## Same Sex/Domestic Partnerships are Step in Right Direction

Domestic-partnership registration ordinances do not create or limit rights or obligations in such areas as inheritance, adoption, child custody, separation, or over 500 related areas governed solely by State law. In fact, local governments in Minnesota may not offer their employees’ domestic partners health coverage akin to that provided to employees’ spouses.

None of the domestic-partner ordinances passed in Minnesota requires any private business or other entity to pay to provide financial benefits of any kind to couples who register. But, it can make it easier for those businesses who would like to **voluntarily** provide health

or other benefits. Businesses would be spared from having to create their own, internal registration process.

There is no evidence that in twenty years' experience, businesses or residents have left, or declined to move to, Minneapolis due to its domestic-partner registration ordinance. In OutFront Minnesota's experience, local leaders express support for such ordinances because they believe they enhance their city's reputation as welcoming to all families and communities, and that this is conducive to welcoming new businesses and residents.

#### **Effect in places of worship.**

A municipal domestic-partner registration ordinance is entirely a function of civil government and has no effect on places of worship. Should a place of worship choose to conduct a ceremony for domestic partners, they are of course free and welcome to do so, but no government entity may require that a place of worship recognize or act on a domestic-partner registration. Likewise, even if the definition of marriage were to be changed to allow for same sex marriage in our current state law, this principal would apply.

According to Rabbi Tilsen of the Congregation Beth El-Keser Israel "a religious marriage (is) subject to the laws of the State, but does not make a State marriage subject to the laws of any religion."

**Bottom line: WE MUST NOT ALLOW THE ELEMENTS OF DISCRIMINATION** (ie. The Marriage Amendment) to be cemented into our state constitution.

# Affordable Care Act

While the AAUW of Minnesota couldn't have anticipated the Supreme Court ruling that saved the essential part of the Affordable Care Act (ACA), the delegates at the April 2012 State Convention passed a proposal that Branches review and discuss the Minnesota Health Plan in the 2012-2013 program year. This is the Minnesota version of a single-payer plan, supported by Governor Dayton, and which, at one point had 70 legislative co-sponsors.

Fortunately, there are a number of resources for learning about health care reform and the single-payer option for achieving comprehensive universal health care coverage.

The Commonwealth Fund is a private foundation working toward a high performance health system - they do not advocate single-payer but they do have excellent information and compare the USA with other countries.

Beyond the Affordable Care Act: An Economic Analysis of a Unified System of Health Care for Minnesota ([www.growthandjustice.org/beyondaca](http://www.growthandjustice.org/beyondaca)). Amy Lange, a policy fellow at Growth & Justice, wrote this very thorough report, basing it on economic modeling done by the national consulting firm, The Lewin Group. It documents how Minnesota could save \$4 billion compared to ACA in 2014, while covering every Minnesotan for all necessary health care. Ann has offered to speak to AAUW groups.

## The criteria for this award are:

A young woman may be nominated for either a high school or college level (up through age 25) award.

The nominee must have shown leadership in a specific action or event that reflects the AAUW Mission: “Advancing equity for women and girls through advocacy, education, philanthropy and research.”

There must be evidence of the impact of the action or event. The evidence must be specific to the nominee’s participation. Measurable outcomes should be shown if possible. These could include any of the following: number of women or girls served, results of the event or research as they impact women or girls, any statistical measures of success, “before and after” stories of women or girls benefitting from the action.

The honorees will be awarded a monetary contribution toward their continuing education and a framed certificate. The recipients of this award will be announced at the State Convention and they will be invited to our convention banquet. Each winner will have the opportunity to speak briefly at the banquet. One parent, guardian, friend, or significant other, accompanying the nominee, may attend the banquet free of charge as our guest. Other family members are welcome but will need to make reservations and pay for their own meals.
