Women's Health, Women's Wisdom **AAUW State Convention 2013**

The MN AAUW 2013 state convention was one of the best! The convention kicked off with late afternoon trolley tours of Rochester and an evening reception at the University of Minnesota-Rochester, University Square.

Saturday's business session opened with a flag ceremony led by Girl Scouts from Rochester. Dr. Lynne Shuster, keynote speaker, followed. Dr.

Shuster shared what is happening in women's health, especially at the Mavo Clinic Medical Center. I'm sure convention attendees learned a lot about their bodies and how women function.



Members voting

Using a consent agenda, the business session went smoothly. One major happening was passing a proposed change to the state by-laws so that co-chairs can exist at each position on the state board level. Since many branches have co-chairs, branches should consider a branch bylaws revision.

The morning concluded with LAF speaker, Lauren Mancuso, a young woman from California, who attended the University of California at Davis. Lauren found that UCD was not in compliance with Title IX,

because the women had to wrestle the men's team, if they wanted to wrestle at all. It took 2 years to find an attorney to take on the case only to have the case thrown out of court, because of the UCD's defense... "UCD didn't know they weren't in compliance with Title IX." In 2005, the court of appeals overturned the case. Finally, in 2011, UCD was found guilty of not providing equal opportunities for women. In 2012, the plaintiffs reached a settlement of 1.35 million dollars. This covered the attorney's fees and cost. AAUW not only supported Lauren with funds (\$110K), but also by AAUW members being present at the hearings. Lauren encouraged us to support cases not only monetarily, but also by being present at the court hearings. Lauren is now an AAUW member in California.

Saturday afternoon was filled with two breakout sessions offering 4 topics, followed by a town hall meeting. Offerings consisted of...

Beyond Tweeting, Texting and Facebook Posting: The Conversation About Gender Pay Inequity in 2013, facilitated by Patty Tanji, co-leader of the Pay Equity Coalition of Minnesota.

Information Patty shared with members:

- 1. Minnesota passed a Pay Equity Act in 1982 for public employees, one of a few states across our nation.
- 2. Minnesota did have an Office of Economic Status of Women, which advocated for pay equity for all women in the state, whether employed publicly or privately. That position is no longer funded, although an office sits empty at the state capitol.
- 3. Patty encouraged convention attendees to contact their senators and representatives to reinstate the Office of Economic Status of Women, as well as, passing a Pay Equity law that would include persons working in the private sector.

Book Discussion

A discussion of *Grace and Grit* by Lilly Ledbetter, was lead by Priscilla Russell. Priscilla led the group discussion by focusing on the title of each chapter and what it may have meant to the reader. Lilly Ledbetter was supported through AAUW Funds/LAF to win her case against Good Year Tire, in which Lilly was unfairly paid working the same position as her male counter parts. I encourage you to read, *Grace and Grit*.

Mission 21: Restoring the Victims of Human Trafficking

Stephanie Holt, Co-founder and Executive Director of Mission 21 in Rochester, presented facts about human trafficking in the Rochester area and in the state of Minnesota. Mission 21 provides young victims of sex trafficking with immediate intervention services, court advocacy and support. Stephanie stressed the need for safe harbor laws in Minnesota to provide education to law enforcement, to make sure that we are not criminalizing the girls who are victims, and to provide safe housing to young girls who are victims of sex trafficking. The group has worked to open the first safe house exclusively for girls 15 years old and younger, who are victims of child sex trafficking in MN. Participants were asked to take action: 1) Educate yourself about the "red flags" – open your eyes, 2) Talk to your men/young boys about this issue and teach them how to respect girls, 3) Call your legislators to promote Safe Harbor Laws, 4) Change your attitude about labeling girls as prostitutes.

Fitness Trends: Zumba

Traci Hussong, a Rochester Athletic Club instructor, led Zumba. Members reported getting a really good workout that was not only beneficial exercise, but also an exercise routine that was fun.

Millie Hoffler-Foushee, AAUW National Finance VP led the town hall meeting with information about what is happening at national:

- 1. AAUW has a new logo.
- 2. AAUW has a new web page.
- 3. Joining online is easy.
- 4. LAF has supported 11 cases and awarded \$100,000.00.
- 5. AAUW can complete 990s for branches needing to file this IRS form without cost to the branch.

Millie made suggestions for the state and branches: 1) Do follow-up with NCCWSL recipients (How are they using their leadership skills they learned? Are they involved in AAUW?); 2) Take advantage of the CQ Track and develop a state version of the 2 Minute Activists; 3) Consider applying for AAUW grants such as Tech Trek and Tech Savvy for 2014; 4) Organize a Student Advisory Council and apply for CAP grants.

The evening's banquet began with great musical entertainment by the "Songs of Friends", a group of 4 women from Rochester. "Songs of Friends" created songs about AAUW, using well-known melodies. They were a delight!

The evening's guest speaker, Julie Kramer, shared about becoming a mystery writer. Julie, entertained questions throughout her presentation and kept the interest of her audience with some humor mixed in.

Many other great things went on at the AAUW State Convention 2013. This is just a brief recap. We are completing the first year of our term as Co-Presidents with a sense of excitement and continued enthusiasm for AAUW and our shared vision.



Two students received a Young Women for Equity Award at the state convention awards banquet, on April 27, 2013. The award is given to a nominee who plays a significant leadership role in a project which addresses the AAUW mission in advocacy, education, philanthropy or research or any combination of these. There must be evidence shown of the impact of the event or action on the recipients, or participants. Any branch may sponsor a nominee.

This year's winners were college student Amber Marie Kling, who attends St. Cloud University, and Emily Bukowski, student at Brainerd High School. Amber was nominated from the Duluth branch, and Emily by the Brainerd branch.

Amber identified the problem of teen suicide to focus on. She thoroughly researched the problem, developed a presentation of facts regarding teen suicide: effects, myths, risk factors, symptoms, things that help, and what to do if you have a friend you think is suicidal. She gave the presentation to various teen and adult groups, and utilized an evaluation form to rate the presentation. Amber received high ratings and many comments including thanks on her evaluation forms, as well as praise from her medical advisors for raising awareness of the problem.

Emily was instrumental in organizing a school-wide toy drive for a women's shelter. She also organized a fundraiser to raise money for a Kiwanis Eliminate Project, for eliminating maternal and neonatal tetanus. Emily coordinated several Red Cross blood drive events, and chaired the Hat Day for cystic fibrosis, in addition to many other volunteer activities.

Each young woman received \$150 to be used toward their education and a framed certificate.

Pay Equity Proclamation

AAUW Minnesota joined the Pay Equity Coalition of Minnesota at the Minnesota State Capitol on April 9th to celebrate pay equity. Lt. Governor Prettner Solon read Governor Dayton's proclamation, declaring April 9, 2013, as State Employee Pay Equity Day. In 1982, the Minnesota Legislature passed the State Government Pay Equity Act, and for the past 30 years, the State of Minnesota has achieved and maintained equal pay for work of equal value for men and women in state government employment.
