Registration will begin at 1:00 p.m. Friday, at the Hormel Historic Home. Free parking is available on the street. You may bring your Silent Auction items at this time as well.

We will begin with optional activities including a tour of the I.J. Holton Intermediate School, a STEAM (Science, Technology, Engineering, Art, Math) school housing fifth and sixth graders. I.J. Holton opened last year in a brand new building designed to facilitate the curriculum. Another optional activity is a visit to

the brand new Austin Artworks Center on Main Street. It is a beautifully renovated bank building that has not only gallery space, but also a lovely retail space with many unique gifts for purchase.

Dinner will begin at 6:00 p.m. with Kate Farrar, AAUW vice president of Campus Leadership Programs, speaking on *"The Next Generation of Women's Leadership"* and the evening will conclude with an historic event: the last performance by *The Spamettes*! They were such a hit at our 2003 convention, that we are bringing them back for one last time. One member of the group has moved to Texas, but she is coming back for our convention!

On Saturday, our keynote speaker, Mark Hopkins, AAUW chief strategy officer, will address *"One AAUW,"* followed by the business meeting. Karen Bull, our LAF plaintiff and Winona State University graduate, will speak during Saturday's luncheon.

Breakout sessions on **STEAM** topics, as well as AAUW themes, will take place after lunch. The Silent Auction will continue throughout the day, ending after the first breakout session – at 2:39 p.m.

# The Next Generation of Women's Leadership

Kate C. Farrar, vice president of AAUW Campus Leadership Programs, manages programs that ensure college women assume leadership roles and acquire the skills they need to succeed in their academic, professional, and personal lives. Her writing has been featured in the Huffington Post and the Daily Muse. Prior to arriving in Washington, D.C., Kate lobbied the Connecticut state legislature on behalf of nonprofit organizations. She earned a bachelor's degree in political science from the University of Connecticut and a master's in public administration from the Maxwell School at Syracuse University.

## LAF SPEAKER

For 21 years, Kathy Bull served as the head coach for the women's tennis team at Ball State University in Indiana. There she advocated for Title IX and mentored young women coaches. But midseason in 2009, the university abruptly fired Bull, allegedly for NCAA violations. Bull, however, claimed she was fired in retaliation for speaking out in favor of gender equity in the school's athletic department — and she promptly filed suit under Title IX of the Education Amendments of 1972.

In July 2013, Bull — who received case support from AAUW's Legal Advocacy Fund — settled her lawsuit with Ball State and was awarded more than \$700,000 in cash and benefits, an outcome she couldn't have attained without LAF and its passionate donors.

"When AAUW came on board, I was at my breaking point," explains Bull. "AAUW brought not only much-needed fiscal support but also the emotional support I needed. All of a sudden this wasn't just my battle; women all over the country were behind me."

# **RESOLUTIONS: How Do I Submit Them?** By Mary Petron, Public Policy VP AAUW MN

Making your voice heard by bringing forth and voting on resolutions is an important concept of our AAUW of Minnesota Convention!

## Who can submit a resolution?

Any branch members, the state board of directors, state standing or special committees, or the resolutions committee can submit resolutions.

## How do I submit a resolution?

**Resolutions must be presented in writing**. Hard or electronic copies may be sent in advance to Mary Petron. If you miss the deadline, you can still submit from the floor. Resolutions may be presented from the floor of the convention for discussion by 2/3 vote of the convention accredited delegates present. THESE MUST BE PRESENTED TO MARY PETRON BY 8:00 a.m. ON APRIL 11, IN WRITTEN FORM OR BY ELECTRONIC FORMAT TO BE DISPLAYED ON SCREEN AT THE CONVENTION. By submitting in this format, your resolution can be shown to convention attendees on a screen. These steps must be followed for the resolution to be heard.

## How do resolutions differ from motions?

A motion is a recognized recommendation or suggestion expressed through common language which may or may not require action. A resolution is the act of finding an answer or solution to a conflict, problem, or formal expression of an opinion, which includes formal language (includes "whereas" rationale and specific implementation). A public policy resolution must be in conformance with national's public policy principles and priorities. <u>www.aauw.org/resource/principles-and-priorities</u> <u>Who reads and considers resolutions?</u>

The resolutions committee is authorized to reword, clarify, or combine submitted resolutions. They will report approved and unapproved resolutions at convention.

## "JUST WHAT DOES THE AAUW MINNESOTA BOARD DO?" A Message from AAUW of Minnesota President, Sharon Bigot

No, none of you have actually asked me this question! Derhaps that is due to "Minnesota Nice." However, this is a good question and I think you will be interested in hearing the answer.

First, I hope you are all aware that \$9.00 of your annual AAUW dues goes to AAUW of Minnesota. This is our main source of revenue.

The AAUW Minnesota Board consists of eight board members elected at the annual convention, four

members alternating every other year, so that only half the board will be newly elected. Each board position is elected for a two-year term. The elected officers of AAUW of Minnesota are president; president-elect; vice presidents for program, membership, AAUW Funds and public policy; secretary/historian; and treasurer. The board has three appointed positions that regularly meet with them: finance chair, Pine editor, and administrative assistant. There are two other positions that are appointed, but they usually do not meet with the Board: website manager and bylaws chair.

Our AAUW of Minnesota Board meets four times a year: July, October, January and April (at the state convention). In the last *Minnesota Pine*, I gave a synopsis of our October board meeting. The following is a general outline of board activities:

• Through our website, <u>http://aauw-mn.aauw.net</u>, we provide branch and state information and highlight branch, state and national activities. In order to accomplish this, we depend on branches sending their bulletins to Teresa Sagen (<u>tksagen@frontiernet.net</u>), our website manager and to me, Sharon Bigot (<u>aebskfb@comcast.net</u>).

• Through our three electronic editions of the *Minnesota Pine* (summer, fall and winter), we provide more in-depth information on board decisions, articles with suggestions from Board/Branch counterparts (president, membership, program, AAUW Funds, public policy) and complete state convention information.

• These board counterparts (president, membership, program, AAUW Funds, public policy) send out updates from AAUW National and other email messages throughout the year to branch presidents and membership, program, AAUW Funds and public policy chairs.

• The Board administrative assistant and president put out an annual **AAUW of Minnesota Directory** which includes the names, addresses, email addresses and telephone numbers of the officers of the state board and all thirty Minnesota branches, Minnesota college/university representatives and AAUW National officers.

• AAUW of Minnesota Board members are available to speak across the state on AAUW issues. We call this program "Leader on Loan" and our Board budget covers the travel cost. Do invite us to come to your branch.

• AAUW of Minnesota provides eleven \$500 NCCWSL (National Conference for College Women Student Leaders) scholarships to branches annually. Do apply for these scholarships! (Sorry, only one scholarship per branch.)

• Through the money we have saved by sending out the Minnesota Pine electronically instead of by USPS, we now provide Branch Project Grants. The total amount available for 2014-15 is \$1000, but \$2000 is in the budget for 2015-16. (This budget needs to be passed at the April AAUW of Minnesota State Convention.)

• Our AAUW of Minnesota State Convention is planned with the cooperation of the Board and the host branch. We elect officers, pass our annual budget, and receive reports from AAUW National, AAUW of Minnesota and individual branches. The convention provides an opportunity to learn through workshops and presentations, plus a chance to meet like-minded women from around our state. The initial convention planning funds, plus any losses from the convention are paid by AAUW MN.

# **PUBLIC POLICY**

Supporting wage equality is imperative for AAUW members. A recently released study, *The Future of Work in Minnesota*, confirms what low wage workers have been saying: "Wages are too low and wage theft, erratic scheduling and lack of paid sick days, are serious problems."

A report by Minnesotans for a Fair Economy found:

- The incomes of most Minnesotans have declined in the past 10 years, when adjusted for inflation.
- Many middle class jobs that paid decent wages and benefits were lost during the recent recession and replaced with lowpay service sector jobs.
- Occupations seeing the most growth in Minnesota pay poverty wages and lack benefits such as paid sick time.
- A growing number of workers have had to adapt to employment arrangements that are unstable and unpredictable.
- Large companies have shifted from employing workers directly to greater use of subcontractors, temporary employment agencies, and workers misclassified as independent contractors.

All of these factors - low wages, lack of paid sick time and retirement security, erratic scheduling and the growth of part-time and contingent work affect people across the state. These problems disproportionately affect women and people of color. Minnesotans for a Fair Economy were a part of a coalition that moved legislators to increase Minnesota's minimum wage to \$9.50 an hour by 2016.

The deadline for mailing in your paper ballot is a postmark no later than 11:59 p.m., May 26, 2015.

The deadline for *online voting* is 9 p.m. PDT, June 19, 2015.

For online voting, you will need your member ID and voter PIN.

The results will be tallied and reported at the San Diego, CA Convention and posted on the website on June 20, 2015.

# WOMEN'S ECONOMIC SECURITY SUMMIT

The 2014 Women's Economic Security Summit meeting last January resulted in the passing of the 2014 Women's Economic Security Act, WESA, signed into law on Mother's Day. This act represents great progress for women and families in Minnesota, but there is more work to do.

Therefore, a 2015 Women's Economic Security Summit was held on Thursday, January 29, 2015. This session was sponsored by the Minnesota Legislative Office on the Economic Security of Women, the Minnesota Coalition for Economic Security\*, the Women's Foundation of Minnesota, WomenVenture and AARP.

Several hundred women and men attended this summit. The session began with a welcome from Barbara Battiste of the Legislative Office on the Economic Status of Women, followed by an overview of WESA—what it achieved, the status of implementation and what is "unfinished." Next, Governor Dayton made his welcoming remarks. The rest of the morning was divided into three separate panel discussions: *Voices of Minnesota's Indigenous and Immigrant Women and Women of Color; 6 of 10 Family Caregivers are Employed: The Impact on Women and the Workforce; and Beyond Roads & Bridges: Bringing the Needs of Women and Low-Income Families into the Transportation Discussion.* The moderators for the first panel were Kenya McKnight of the Black Women's Business Alliance and Fartun Weli of Isuroon. Lori Sturdevant of the Minneapolis Star Tribune moderated the second panel and Lorrie Janatopoulos of the Arrowhead Economic Opportunity Agency and the Governor's Workforce Development Council moderated the third panel. The closing and call-to-action was given by Lisa Stratton of Gender Justice.

The Minnesota Coalition for Women's Economic Security 2015 Women's Economic Security Agenda, which is broken down into three general issues:

- Ensure affordable, accessible childcare for all Minnesota families (support the Kids Can't Wait campaign).
- Provide additional opportunities for working families to fulfill their caregiving responsibilities.
- Place and retain more women (who are increasingly the primary breadwinners for their families) in non-traditional, high-wage jobs.

The Coalition will continue to be an ally for issues of reproductive justice, retirement security, transportation accessibility, and the ERA.
