President's Message

The hyper speed at which time moves is unsettling. I went to bed after the AAUW Holiday Social and when I woke up it was January 2, 2016. Speaking of the Holiday Social, it was a lovely way to begin my new warp speed time travel. Thanks to Vikki Amundson, Pam Sullivan and Peggy Horsch for pulling this wonderful event together.

I have been following the progress of Saudi women on a number of fronts. A December 10th article by the Associated Press noted that "Saturday's (December 12, 2015) vote for local council seats marks two milestones for Saudi women: not only can they run in a government election for the first time, it is the first time that they are permitted to vote at all." There were 979 female candidates and 5,938 male candidates vying for 2,100 council seats. This factoid is even better--about 130,000 women had registered to vote versus 1.35 million men.

Drum roll for the results - on December 14th, Saudi Arabians elected their first female officials, voting at least a DOZEN candidates into seats on municipal councils. This fact is so impressive because the ultra-conservative Saudi Arabian monarchy imposes some of the world's strictest limitations on women. Women candidates were forbidden to address male voters and had to speak from behind a partition or have male relatives speak for them.

In 1932 the Kingdom of Saudi Arabia came into being as an Islamic State with Arabic as its national language and the Holy Qur'an as its constitution. In 1964 the first public schools for girls were established. As noted above, women gained the right to vote on December 12, 2012.

For comparisons sake, the United States became an independent country in 1776. Women gained the right to vote on August 18, 1920, with the ratification of the 19th Amendment.

AAUW HASTINGS BRANCH – GENERAL MEETING MINUTES November 23, 2015

PRESIDENT: Pam Pontzer. Pam called the business meeting to order at 7:06 p.m., welcoming 42 members and guests. Pam noted a Fall 2015 AAUW Outlook article about Title IX, commenting that beyond athletics, there are other areas that Title IX coordinators are supposed to be overseeing, including monitoring the gender ratio in science, technology, engineering and math courses, working to monitor and end sexual harassment and support pregnant and parenting students. Pam also commented on a Star Tribune article about Title IX, written by columnist, Lori Sturdevant, about University of Minnesota interim athletic director, Beth Goetz, and current statistics regarding collegiate athletic directors, including that only 32 in 351 Division 1 athletic directors (9%) are female. This is a dismal representation 43 years after Title IX became law. Pam noted that when the U of M merged the men's and women's athletic departments in 2002, State Representative, Phyllis Kahn, the sponsor of the landmark legislation that required gender equity in school sports, stated, "I don't think there's any question but that men will dominate a merged department unless there's a woman at the top." Resigned athletic director, Norwood Teague's tenure seems to give credence to Kahn's statement. His tenure includes a \$175,000 settlement payment to a female administrator he fired after she questioned his commitment to Title IX compliance, and the design of a new \$166 million Athletes Village to be dominated by football and basketball, while displacing women's track and field. These incidents led to a 2014 discrimination complaint to the federal Office of Civil Rights. Two investigations are ongoing; and it appears that U of M leaders will wait until they're completed before deciding on a search process for a permanent athletic director. Pam suggested that members keep an eye on this; and if any member is a U of M alum, a phone call to Eric Kaler would be helpful.

SECRETARY: Lisa West. Lisa submitted meeting minutes from the October 26, 2015, general meeting that were published in the Twig. Motion by Pat Powers, and seconded by Lisa Hedin to approve the general meeting minutes as printed in the Twig. The motion was unanimously approved.

TREASURER: Nancy Techam. Nancy summarized October expenses and reported a month-end checking account balance of \$6,002. Motion by Glenda Schnirring, and seconded by Pat Schultz to approve the October Treasurer's Report. The motion was unanimously approved.

COMMITTEE REPORTS

MEMBERSHIP: Janet Grove and Pat Hanson. Pat and Janet introduced four guests present. Members are encouraged to take AAUW program bookmarks and AAUW Hastings brochures.

PROGRAMS: Peggy Horsch and Pam Sullivan. Pam informed members that the December program will be our annual holiday social on December 14 at the new Arts Center on 4th Street. Pam thanked Vicki Amundson for her lead role in assisting with this event. A refreshments sign-up sheet was circulated.

GAD-ABOUTS: Cindy Toppin and Sue Cruse. Cindy informed members of the December 8 outing to the Lowell Inn for High Tea and shopping; payment of \$17.00 is needed by December 1. A January 20 event will be a tour of the Union Depot, in downtown St. Paul, with lunch at Christos. The tour is free.

BOOK CLUB: Shirley Tammen. Shirley reminded members that "The Linde Sampler," a collection of essays and short stories by AAUW member, Lew Linde, is the focus of the Monday, December 7 meeting (note the date change), to be hosted at Shirley's house. The January 11, Book Club meeting will discuss the Hastings Reads adult reading choice, "The Life We Bury," by Allen Eskens.

PUBLIC POLICY: Pat Powers. Pat discussed the AAUW emails she's been receiving, noting the AAUW focuses on sexual violence on college campuses; rape dating violence and stalking; Arnie Duncan, Secretary of Education stepping down; AAUW members hand-delivering tools/materials to Title IX coordinators; the longest serving woman in Congress retiring and receiving the Presidential medal; Senate Democrats social security changes; the Pentagon rise in women entering the Officer Core; and how AAUW impacts \$3.7 million, conducting 1,200 Congressional office visits and visiting 140 college campuses.

TWIG: Lois Twedt. Lois mentioned that if any member is not receiving the Twig, or if members have any other issues with the Twig of notices sent, to let Lois know.

NCCWSL: Gail Glashan. Pat Powers informed members of the status of the NCCWSL, mentioning that we're now looking for 2016 NCCWSL candidates. Flyers are being posted around town, and more were handed out at the meeting. Pat emphasized how important the programs offered at NCCWSL are and that applications are due January 2, 2016. We have the funding ready for this year's candidate.

COMMUNITY: Margaret Goderstad. Margaret mentioned that the LeDuc Historic Estate will be open the next three weeks on Saturday and Sunday for holiday shopping. On December 20, Terry Flower will present his "Star of Bethlehem" talk.

ADJOURN

Motion by Betty Hoeschen, and seconded by Cindy Toppin to adjourn the business meeting. The business meeting was adjourned by unanimous vote at 8:30 p.m.

Nancy Techam introduced the evening's speaker, Bonnie Bzdok, whose presentation was entitled, "Little Falls to Uganda." Bonnie represents Resilient Uganda and brought along items made by the women of Uganda for purchase.
