Post-retirement, Baldwin embarked upon her second career as a “professional volunteer.” Baldwin was a tutor and mentor with the St. Paul Public Library’s Reading Together program. She was a volunteer in elementary schools in her local school district and Junior Achievement of the Upper Midwest (JAUM). In 2018 she was named a JAUM All-Star in recognition of her service.

Volunteering with elementary students caused her to reflect on the education she had received while attending a Lutheran grade school. She realized that God was calling her to start a school accessible to families regardless of income. Relying on the micro-school concept (a re-invention of the one-room schoolhouse), in the fall of 2021, Baldwin opened Laurel Community School. Laurel serves students in grades K-8. Baldwin’s vision is to plant Christian micro-schools across the Twin Cities.

Baldwin serves on the Board of Directors of the Minnesota South District of The Lutheran Church—Missouri Synod. She is also board Chair for TakeCharge MN, an organization dedicated to restoring the Black community’s cultural roots of faith, family, and education.

Baldwin holds a bachelor’s degree in Political Science from Knox College and a Juris Doctor from DePaul University College of Law.

Hastings Branch Grieves Two Hastings Branch Founders

The passing of two charter members of our AAUW branch provides the poignant pause of a time more than 50 years ago when two distinguished graduates from St. Theresa College, Winona, MN, moved to Hastings and became educators in its school system. In time, Patricia Giddings and Anita “Fran” Schoen chose to be among the first rostered members of the newly formed Hastings Branch of AAUW. They both served AAUW with dedication and loyalty through leadership roles and continued to devote their respective energies to the progressive initiatives of the branch for decades.

Fran Schoen, 86, died on Jan. 21 in Minneapolis. A memorial service will take place on Saturday, April 30, at 1 p.m. at the Hastings Golf Club followed by a celebration of life until 4 p.m.

Patricia Giddings, 98, died February 5, in White Bear Lake, MN where she was in hospice care. A visitation for Pat is on Friday, February 25, from 4 to 7 p.m. at the Starkson Funeral Home. Pat’s funeral will be on Saturday February 26, at 11 a.m. with visitation one hour prior. Hastings AAUW has been named as a designated memorial recipient for Pat Giddings. As an AAUW branch, we embrace the memories of these two women who ignited something very special for those of us who follow them.

Call for Resolutions:

If you have a resolution to go to the State Annual Meeting, now is the time to bring it forward. If you don't remember what the resolution for the State Annual Meeting is all about, I can remind you.

Last year the AAUW Hastings Branch offered a resolution about the Education Opportunity Gap. There are many significant issues that you may want to see our branch forward to the 2022 Resolutions. Contact me pat.pow01@gmail.com and I will help you format and submit to the resolutions committee. At the end of the TWIG, there is an AAUW MN Resolutions Template and a copy of the resolution that our branch submitted last year.

AAUW MN Public Policy Priorities:

The bylaws direct the Public Policy Chair to review the priorities every 2 years and present to the State Board. At the Board meeting there was discussion of the list with suggestion to eliminate or further prioritize what had been established. It was decided that the priorities should be accepted and let the Branches decide if they wanted to focus on specific items. This list is impactful. It fits the goals of the Strategic Plan. In recruiting new members, this list says who we are. For many new members the Mission is described in these priorities. There will be a bookmark or brochure published for visibility of the priorities.

1. Economic Security for All Women

- Equity in the workplace
- Equal Pay
- Enforcement of anti-discrimination statutes
- Security in retirement
- Access to job training for career development
- Work-life balance, including access to quality affordable childcare and paid sick and care-giving leave

2. Equal Access to Quality Public Education for All Students

- Vigorous enforcement of Title IX
- Adequate and equitable funding at all educational levels, including pre-school and post-secondary
- Instruction in STEM fields

- Opposition to the use of public funds for schools that do not meet public school civil rights and accountability standards

3. Social and Racial Justice for All Members of Society

- Self-determination in reproductive health
- Equal access to quality affordable health care
- Freedom from violence in all its forms and wherever it occurs, including racially-motivated violence
- Guarantee of civil and constitutional rights for all
- Protection and expansion of voting rights

AAUW Business Meeting

January 24, 2022

1. President Lisa Hedin called the meeting to order at 7:04 pm.

In her greeting, she recommended reading the excellent January TWIG, which contains much good AAUW information, such as the progress report on our branch's recently adopted Strategic Plan, which is well on track. Some of the goals and activities yet to be completed have already been started. She noted that one of our new members, Cheryl Read, has volunteered to take over as Webmaster for the branch.

The minutes of the November meeting were approved as published. Motion: Glenda Schnirring; Second: Kathy Palmer.

2. Treasurer's Report: Carol Tobin

Our financial situation continues to look strong. Our budget balance in November was \$3,674.64; at the end of January the balance was \$4,826.06. Also our CD has come due. The interest earned is \$72.97 for a new balance of \$3,721.71.

The Treasurer's Report was accepted. Motion: Danna Elling-Schultz; Second: Susan Cruse.

3. Committee Reports

a. **Membership:** Kathy Palmer reported that three new members joined in December. The official total of branch members stands at 90.

b. **Program:** Danna Elling-Schultz. February (Equity, Dr Alfrieda Baldwin; March (Title IX, Cathy Moen, ISD 200); April (Non-traditional professions: Claire Ferrar) and May (Inspiration/Writing, Diane Saed). The April meeting will be held at St Philips this year, rather than our traditional paid catered spring event.

c. **Public Policy:** Pat Powers noted there will be a rally at the Capitol rotunda, co-sponsored by AAUW, on January 31st in support of the 28th amendment to the U.S. Constitution, the Equal Rights Amendment. The State AAUW Convention is planned for April 29-30 in St. Cloud, in-person.

A State AAUW event is in planning to mark the 50th Anniversary of passage of Title IX on June 23, 2022. Pat also listed some achievements of the Biden administration to date relating to women's economic security, e.g., the Defense Production Act, the American Rescue Act, the increased availability of Affordable Care Act health insurance.

d. **Book Club:** Shirley Tammen listed the many excellent upcoming events of the Book Club and Hastings Reads and encouraged members to participate. See TWIG and Hastings Reads for all details.

e. **AAUW Funds/HHS Scholarship:** Glenda Schnirring reported that the Hastings branch's donation of \$1000 to AAUW National objectives of "Greatest Need" has finally been confirmed as received by AAUW National.

She said that HHS Scholarship award selection will happen in late April. Anyone interested in serving on the selection team should please contact Lisa Hedin or Glenda Schnirring. Three people will be needed in addition to Glenda.

f. **Gad-Abouts:** Cindy Topping has purchased 17 tickets @ \$22 for a performance of movie themes by Colleen Raye and the St Croix Valley Orchestra on Friday, April 8, 2022, at 1:30 pm, Sheldon Theater. She was circulating a clip-board for in-person members interested in attending. Members on Zoom who are interested were asked to mail their checks to Cindy's home. Possibly, the group will be able to lunch at the St James Hotel before the performance. More details in the next TWIG.

g. **NCCWSL.** Gail Glashan announced the annual NCCWSL conference will be held online May 24-26, with ten scholarships to be offered by AAUW Hastings. Members will receive a Sprout soon with details for applications, deadline March 15.

h. **Community.** Margaret Goderstad listed several upcoming events at the Hastings Art Center, as well as a scotch tasting at the LeDuc Mansion. See HAC and Dakota County Historical Society websites for details. Also, a River Valley Band Children's Concert is planned for Sunday, March 6, 3 pm at the Hastings Middle School Auditorium.

i. **Diversity:** Peggy Horsch thanked all the members who attended Ellie Krug's Zoom presentation on January 5.

AAUW of Minnesota Resolution
March 16, 2021
Resolution from AAUW Hastings Branch

Whereas, Systemic Racism emerges from policies, often unseen, that turn racism into something hidden and unknowable which affects societies and institutions and

Whereas, dramatic inequalities/disparities exist in Minnesota high school graduation rates between white students and students of color positioning Minnesota 47th in the disparity level in 2021, resulting in 64.8 % of Minnesota's black students graduating (Ciresi Walburn Foundation for Children report), as compared to 89% of white students and

Whereas, fact based evidence states that 4% of the 63,000 Minnesota educators are teachers of color or Native American negating the ideal of students having teachers who mirror their heritage being significant and it's known Pre K-12 classroom populations are 35% students of color or Native American and

Whereas, communities of color have a diminished access to health care which affects educational preparedness and success and

Whereas, access to housing for non-white populations has been controlled by policies that discriminate in areas of mortgage interest rates, home insurance rates, and redlining of areas where non-white persons can live and

Whereas, white privilege ensures that whites have access, which may be known or unknown, for building lifetime assets as enabled by post WWII GI bill and Veterans Administration housing legislation, both of which were granted only to Caucasian veterans, resulting in minimal accumulated wealth for blacks thus curtailing the passing on of accumulated assets and

Whereas, voter suppression efforts are targeted at communities of color and the indigent making the objective of a democratic system of governance riddled with barriers and

Therefore, be it resolved that AAUW of Minnesota supports closing the academic opportunity gap for all students with a special emphasis on students of color and working toward greater awareness among AAUW of Minnesota's membership and the greater community regarding existing educational disparity through advocating for greater financial and educational system access which would lead to better high school completion outcomes.

Implementation:

The AAUW of Minnesota Board will make an intentional effort to give voice to branches about equity at the center of Pre K-12 public education. Educate members by making one program available annually statewide for aauw members on education achievement gaps.

Branch Public Policy chairpersons will provide no less than 5 advocacy alerts annually to AAUW MN members regarding state level legislative actions regarding disparities in education which will inform members of issues important to the mission of AAUW and direct them to weigh in as activists on legislation that is beneficial to improving equity in educational performance between BIPOC and white students.

AAUW branch presidents will provide direction for members to support their local public schools to help close the educational gap. Support could include partnering with other like minded organizations on one event annually to raise community awareness regarding racial educational gaps.
