# President Jan Carey's Goals for 2022 - 2024

Goal 1: <u>AAUW branches need to increase visibility in order to increase membership</u>. Together, they hope to improve communications among and between branches and AAUW of MN.

Goal 3. Implement the Strategic Plan. Each Strategic Plan Goal has associated actions to be taken by the Board. By appointing Anna Voight to the Carol MacPherson Memorial Scholarship Board, we have already taken action to partially implement the Education Goal "Champion equal access to all levels and fields of education."

# July 30, 2022 Board Meeting

The Board met for the first time at Hickley on July 30<sup>th</sup>. We got to know each other and learned about the procedures we will be employing in our Board and officer positions. We agreed to try to improve communications by holding ZOOM meetings with officers holding the same offices at the branch level. Jan reported that when she was VP Public Policy holding ZOOM meetings with branch VPs for Public Policy helped the group be more effective. Branch officers will soon be hearing from Board members to set up these ZOOM meetings.

In addition, the Board will be identifying and implementing other means of improving communications with and among branches. We will be adopting some of the ideas other states are using, such as California and Pennsylvania. Suggestions are welcome.

Jan also reported on her activities at the national level. The National Advancement Committee has determined that the most significant issue facing AAUW, at all levels, is declining membership. The committee found

that the vote on whether to dispense with the education requirement for membership failed largely because so few members voted. In MN, of the 1,718 eligible voters, only 437 voted. The MN vote was 285 Yes, 14 No and 12 abstained.

Jan also serves on the Inclusion and Equity Committee, which is tasked to improve diversity awareness and inclusion within AAUW membership. She recommended that branches make use of the Diversity/Equity/Inclusion (DEI) Toolkit and the DEI Plug & Play Programs.

The Board adopted a calendar. See below and announced that the 2023 AAUW MN State Convention/Annual meeting will be held via ZOOM on Saturday April 29, 2023.

Because this was the first meeting of a new Board, members did not provide reports. In the future, the substance of the reports will be published in *The Pine*.

# **NCCWSL**

The new AAUW of MN website editor, Ashley Sarne, a student at Dakota County Technical College, attended the virtual NCCWSL conference on May 24–26, 2022. She was sponsored by AAUW Hastings Branch. She shared her experience as part of an article in the August 1<sup>st</sup> DCTCNEWS. Asley had this to say,

"If I were to be asked which session was my favorite, it will be a difficult choice because each has its own unique way of leaving me with so much knowledge, inspiration, and encouragement. It was a struggle choosing which session to attend per schedule, but the good thing was that other sessions were recorded. These sessions truly contributed to my personal and professional growth.

"Hearing the stories behind the success of these women who have achieved so much within their profession was motivating. Behind success comes struggles, and hearing what it took for these women to be where they are now made me realize that they are humans, too, and they were once young and still trying to navigate the world around them—like me today.

"Their success did not happen overnight and their path to success is not linear from point A to point B, but rather more branch-like. Their stories gave me motivation that I can be successful like these women someday, excelling in my career path, being a voice of change, and empowering young women."
