AAUW MN Annual Meeting – April 29, 2023 President's Welcome & Statement

On behalf of the AAUW Minnesota Board of Directors and Committee Chairs, I welcome you to the 94th AAUW Minnesota State Annual Meeting, previously known as the State Convention. Our theme this year is "Hear Us Roar". And many have heard us and will continue to hear from us as we champion AAUW's Mission and AAUW Minnesota's Strategic Plan Actions.

For over 140 years, AAUW (American Association of University Women) has fostered its mission of "equity for women and girls through advocacy, education and research". We have given thousands of women a voice in the quest for equality and equity.

As members, you know that AAUW has thoroughly researched and examined inequities toward women and girls. Its published research studies are acclaimed. Economic Security, Education, Title IX, and Civil Rights are critical issues for women and girls of Minnesota and America.

It is difficult to comprehend that now, in 2023, equality under the law, for women and girls in Minnesota, continues to be debated & challenged. And that is why AAUW MN has partnered with ERAMN to promote State legislation to enact gender equity as Minnesota Constitutional law. Adding ERA to the Minnesota Constitution through a ballot initiative is being sought. Our advocacy with ERAMN parallels AAUW MN Convention Resolutions passed at previous State Conventions and Annual meetings. When passed, Minnesota will join 27 other states who have recognized equity for women by enacting state Constitutional amendments. These 27 states have passed state equal rights amendments (ERAs) to their constitutions that provide various degrees of legal protection against discrimination based on sex.

Hopefully, by the time our Annual meeting convenes, the Minnesota Legislature will have passed this vital legislation.

Meanwhile, AAUW MN has completed other goals, objectives and actions in its Strategic Plan.

2022/23 Strategic Plan Accomplishments:

- Promoted branches to utilize programs created by AAUW National
- Continued scholarship opportunities for women

- Supported Branch STEM initiatives and programs
- Tracked State and National legislation in key areas of pay equity, women's healthcare, Title IX, ERA
- Continued scholarship support for the NCCWSL initiative
- Recruited members to serve in AAUW MN leadership positions
- Updated AAUW MN Website and employed a Website manager
- Utilized the AAUW MN FB page as a communication tool
- Established partnership with organizations that parallel our mission
- Established monthly ZOOM meetings between board leadership position and branch counterparts; i.e. Presidents, Membership, Programs, Funds, Public Policy, etc.
- Improved AAUW MN visibility by publishing Opinion columns (OP Eds) and Letters to the Editor (LTE)

AAUW MN board members have paved roads to consistent communication. The board listened to branch leaders as they expressed their views in our Board-to-Branch interviews. The Board set out to seek remedies and give attention to concerns. We have more to do. But the lines of communication are open and we are ready to remedy any issue or concern.

She was Chief author of dozens of bills, but her primary focus has always been on Women's Rights and Equality. In 2014, she founded ERAMN and since then has maintained an unprecedented passion for women's equality and gender equity.

AAUW MINNESOTA 93RD ANNUAL STATE MEETING April 29-30, 2022 Park Event Center, St. Cloud, MN

OPENING PROCEEDINGS

Call to Order: President Mary Ann Lucas Houx called the State Meeting to order at 5:00p.m. on April 29, 2022. She welcomed all attendees and thanked the St. Cloud Area Branch for hosting the meeting and sharing their 100th anniversary celebration.

Recognitions: President Houx recognized and thanked those who have served as past presidents of AAUW Minnesota. She announced that a gift of \$300 had been given in their honor to the Greatest Need Fund. President Houx also recognized and thanked 50-year Honorary Life Members.

AAUW CEO Gloria Blackwell: Gloria Blackwell addressed the meeting via Zoom. She reviewed recent successes of AAUW in addressing the basics of our mission: education, advocacy and research on behalf of women and girls. She outlined the focus areas of AAUW's Strategic Plan: Education and Training; Economic Security, Leadership; and Governance and Sustainability and concluded with a call to action by all AAUW members.

Evening Program: Following dinner, Linda MacLeod, President of the St. Cloud Area Branch, presented the all-women color guard, and the National Anthem was sung by Nancy Hamilton. Linda then introduced special guests: President Robbyn Wacker of St. Cloud State University; Dr. Lori Putman, incoming St. Cloud Superintendent of Schools; and Tarryl Clark, Stearns County Commissioner. The St. Cloud Area Branch then presented a decade-by-decade retrospective of their past 100 years, with current members in the roles of former members reviewing the major activities of the branch. The evening program ended with music by a jazz trio and singers.

BUSINESS MEETING

President Houx called the Business Meeting of the Annual Meeting to order at 9:00a.m. on Saturday, April 29, 2022. She then recognized several groups: our college and university representatives, those who have served on National and State boards and committees; and current State Board members. She then called on Jan Bensen, St. Cloud Area branch member, to offer a memorial remembrance of David Kirkwood who had been a member of the St. Cloud branch, the State Board, and the National Board of Directors. President Houx announced that the AAUW MN Board had donated \$5,000 to the Greatest Need Fund in David Kirkwood's memory.

Roll Call: Secretary Linda Blaisdell called the roll of Minnesota branches, and 22 branches responded as present: Albert Lea, Alexandria Area, Austin, Brainerd, Duluth, Ely, Faribault, Fergus Falls, Grand Rapids, Hastings, Hibbing, Metro West, Minneapolis, Northeast Metro, Owatonna, Red Wing Area, Rochester, St. Cloud Area, St. Croix Valley, St. Paul, Willmar and Winona. She announced that a quorum was present to conduct business.

Credentials Report: Teresa Sagen, Administrative Assistant, presented the Credentials Report. She stated that there were 136 registrations for the Annual Meeting, with 9 guests. Further, she reported

that there were 90 eligible voters in attendance: 82 as branch delegates, 4 as past State Presidents; 4 as State Board members, and no College/University Representatives. **Teresa then moved the adoption of her report, and the motion carried.**

Standing Rules: Barb Liukkonen, Chair of the Standing Rules Committee, moved the adoption of the Standing Rules as printed in the meeting booklet. There was no discussion. The motion carried.

Minutes of the 2021 Annual Meeting (via Zoom): Secretary Linda Blaisdell, on behalf of the Condensing Minutes Committee, moved that the minutes of the 2021 Annual Meeting as printed in the meeting booklet be approved. There were no questions or discussion, and the motion carried.

Annual Meeting Appointments: The St. Cloud Area branch recommended the following appointments for the Annual Meeting: Pages: Ginny Bisel, Roberta Lampi; Tellers: Sandra Williams, Mary Lou Lenz; Timer: Jonna Pucel. **The appointments were approved by the delegates.**

Treasurer's Report: Treasurer Beth Nienow presented her report for the 2020-2021 fiscal year which was printed in the meeting booklet. There were no questions or discussion, and President Houx announced that the report as printed would be placed on file.

AAUW Funds Report: Barb Liukkonen, Interim AAUW Funds Vice President, presented her report on Minnesota branch gifts found in the booklet. She corrected the amount of Fund # 9110 to be \$80,364.08. She reported that the discrepancy between totals was due to the fact that National did not credit some branch gifts made in December, 2021, until 2022. Barb is working with branches to straighten out the situation so that they will receive the credits in either 2021 or 2022, whichever they prefer. **Barb Liukkonen then moved the adoption of the 2021 Funds Report, as corrected. There was no discussion, and the motion carried.**

Financial Records Review Committee: Chair, Jan Bensen, presented the Financial Records Review report as printed in the meeting booklet and moved its adoption. There were no questions or discussion, and the motion carried.

2022-2023 Budget: Janice Quist, Finance Chair, presented the proposed AAUW MN budget for fiscal year 2022-2023. **By the direction of the Finance Committee and the State Board of Directors, she moved the adoption of the proposed budget as printed in the meeting booklet.**

Nominating Committee Report: Chair Barb Liukkonen presented the slate of officers for July 1, 2022 – June 30, 2024:

Barb Liukkonen asked for nominations from the floor for the AAUW Funds Vice President position, and there were none. She asked for any further nominations from the floor, and there were none. **The slate**

of nominees was approved by the vote of the delegates, and Secretary Linda Blaisdell cast the elective ballot for those nominees.

Public Policy: Vice President for Public Policy, Jan Carey presented the Public Policy Priorities/MN Legislative Agenda for 2022-2024 found in the meeting booklet and in the brochures distributed to each table. **She then moved their acceptance. There being no discussion, the motion carried.**

Resolutions: Jan Carey, Vice President for Public Policy, explained the process for submitting resolutions from the floor since the committee had not received any resolutions prior to the Annual Meeting. **The rules establishing a time limit for discussion of resolutions were voted on and approved**. The following resolutions were presented from the floor:

- Resolution #1 submitted by the Ely branch: "AAUW Minnesota actively supports and advocates
 for passage of the Equal Rights Amendment within the State and on the National level."
 Resolution #1` was approved.
- Resolution #2 submitted the Ely branch: "Branches in Minnesota will actively work to become
 inclusive in their membership, education, branch activities, and advocacy."
 Resolution #2 was approved.

Jan Carey announced that the full text of the resolutions would be placed on the website and printed in *The Pine*.

Recognition of Board Members: Outgoing Board members, Linda Blaisdell, Cyndy Harrison, and Gail Glashen were thanked. The 2022-24 Board members were recognized: Jan Carey, President; Beth Nienow, Treasurer; Saundra Martell, Secretary/Historian; Deanna Ensley, VP Program; Pat Powers, VP Membership; Kelsey Waits, VP Public Policy; Janice Quist, Finance Chair; Teresa Sagen, Administrative Assistant, and Anna Voight, College/University Representative.

Recognition of Mary Ann Lucas Houx: Incoming President Jan Carey expressed our gratitude and appreciation to Mary Ann for her outstanding leadership and announced that a gift of \$300 will be made in her honor to the Greatest Need Fund of AAUW.

President Houx declared that the Business Meeting of the AAUW Annual Meeting was adjourned.

The remainder of the Annual Meeting was comprised of presentation of awards and distinguished speakers.

Gail Glashan referred the delegates to the meeting booklet for the listing of the branches that had received Strategic Action Plan Grants, NCCWSL grants, and the ZOOM grants. She then announced the Young Women for Equity Awards:

Barb Liukkonen announced the AAUW Funds Awards as shown in the meeting booklet:

- Barb also announced the Named Honorees for each gift of \$750 to AAUW Funds

Dr. Joy Plamann, Senior Vice President of Central Operations of CentraCare and President of St. Cloud Hospital, was the keynote speaker. Dr, Plamann spoke about health care trends: where we've been, lessons learned from Covid, and how we're headed toward a consumer-centric health care system and personalized medicine.

- Electronic votes should be recorded in the minutes of the next board meeting following the vote.
- Outstanding checks and deposits should be listed on the bank statements to avoid having to recalculate the reconciliation.
- An entry to balance the actual financial result is confusing. FY 2022 had a loss of \$1,781.70 and should be reported as such. This would also be true if the year ended with a surplus.

Resolution #1

ERA IN MINNESOTA CONSTITUTION

WHEREAS the 2021-2023 National AAUW Public Policy Priorities directly call for the passage and ratification of the ERA. AND

WHEREAS the Minnesota Constitution does not have an Equal Rights Amendment (ERA). AND

WHEREAS the lack of constitutional equality reaches every aspect of women's lives. The ERA would clarify, once and for all, that sex discrimination in employment and wages, reproductive rights, insurance, Social Security, education, and more is a violation of constitutional rights. Importantly, the ERA would also <u>provide new opportunities</u> to seek legal recourse when an individual faces sex discrimination and would place the burden of proof on those who discriminate instead of those fighting for equality. AND

WHEREAS Minnesota AAUW is one of the Allies of ERAMN.org. AND

WHEREAS there are companion bills in the Minnesota Congress, HF00173 and the SF0037 with inclusive Equal Rights Amendment companion text: The proposed amendment must be submitted to the people at the 2024 general election. If ratified, the amendment is effective January 1, 2025. The question submitted must be: "Shall the Minnesota Constitution be amended by adding a specific guarantee that equality of rights under the law shall not be denied or abridged by this state or any of its cities, counties, or other political subdivisions on account of race, color, creed, sex, sexual orientation, gender identity or expression, age, disability, ancestry, or national origin. AND

THEREFORE, BE IT RESOLVED that AAUW Minnesota will vigorously support passing the ERA for the Minnesota Constitution.

IMPLEMENTATION: The AAUW Minnesota State Public Policy VP will provide the information in this resolution to the branches to provide to their members and encourage them to contact their Senators to pass SF0037 and their Representatives HF00173.

Resolution #2

Ratification of ERA

WHEREAS the 2021-2023 National AAUW Public Policy Priorities directly call for the passage and ratification of the Equal Rights Amendment (ERA.) And

WHEREAS the ERA was first introduced in Congress in 1923 and was ratified by 35 of the necessary 38 states by 1977. However, Congress imposed an arbitrary deadline to complete ratification by 1982. With the ratification by Nevada, Illinois and finally Virginia in 2020, we are now closer to the finish line than ever. Now, Congress must do its part to make women's constitutional equality a reality. H.J. Res. 25/S.J. Res. 4 would remove the deadline for ratification, allowing states like Nevada, Illinois and Virginia to count toward ratification, and recognize that the ERA is now the 28th Amendment to the U.S. Constitution. And

WHEREAS the Equal Rights Amendment (ERA) would, once and for all, guarantee constitutional equality between men and women. Its ratification would provide the constitutional guarantee that all men and women are truly equal under the law and that these rights cannot easily be abridged.

WHEREAS the ERA has 3 sections: Section 1: Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex. Section 2: The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article. Section 3: this amendment shall take effect two years after the date of ratification.

THEREFORE, BE IT RESOLVED that AAUW Minnesota will vigorously support ratification of the ERA in the 118th Congress.

IMPLEMENTATION: The AAUW Minnesota State Public Policy VP will provide the information in this resolution to the branches to provide to their members and encourage them to contact their Senators to pass S.J. Res. 4 and Representatives to pass H.J. Res. 25, a joint resolution to remove the deadline for ratification of the ERA in the 118th Congress (2023-2024).

The AAUW priorities are what women see as common goals.

An AAUW MN Strategic Plan for 2021–2026 was approved in 2021 by the AAUW MN Board and is closely aligned with the focus of the AAUW National Strategic Plan. The plan includes four goals: Education and Training, Economic Security, Leadership, and Governance and Sustainability. The board approved grant money to help Minnesota branches implement the Strategic Plan Actions, working to achieve AAUW's mission: To advance gender equity for women and girls through research, education, and advocacy.

These awards are based on a project or activity specifically addressing women's and girls' equity issues, reflecting AAUW's mission.

The Leader on Loan Program provides branches the opportunity to have a board member, team of state leaders or teams of past leaders provide branch support.

AAUW MN has made a new connection by teaming up with the Carol E. Macpherson Memorial Scholarship (CEM). This is a private family scholarship for women who have a five-year or longer accumulative gap in their post-secondary education and who are attending or have been admitted to Minnesota colleges and universities. AAUW MN Branch Highlights 2022-2023

AAUW Albert Lea

One of the Albert Lea branch program highlights was a presentation by Stacy Lang, the daughter of Barb Lang, AAUW Program Chair for 20 years. Stacy's career is in designing costumes for movies and celebrities. Stacy spoke about her career using a PowerPoint to a crowd of ninety people at the Marion Ross Theater. Her folks, Neil and Barb, managed this theater for many years. Our fundraiser was a great success!

AAUW Austin

The Austin Branch has had a lively year starting with an Ice Cream Social in August and local candidate forums live-streamed on Facebook in October. We had a social event in December with members bringing books to exchange.

In January, we hosted our third annual Story Show for scholarships to Riverland Community College. Various community members graciously agree to share their stories on a topic, which this year was "Opportunity". We raised over \$4000.00 through this event.

In March, we are hosting our annual Women's History month assembly at Austin Senior High School and sponsoring Women's History projects in the AP History class.

We have also had a professional financial planner talk to our members about the importance of women taking control of their own finances no matter what stage of life we are in.

We also have two active book groups, a Great Decisions group, a Travel Group, and a once-a-month just come lunch.

AAUW Brainerd Lakes Area

Brainerd hosted the **Northland Get Together in October 2022**. Six Northeastern Minnesota AAUW branches participated in the gathering. There were 45 participants at the NGT. It had been several years of planning due to covid.

The theme keynote workshop focused on understanding Indigenous and Immigrant Women's challenges. A panel of women presenters shared powerful life stories about historical trauma, epigenetics and how trauma changes the genes, the ways in which women have to adjust to the challenges to help their family and community survive. The afternoon program included holiday decorating tips from a local business owner and Master Gardener volunteer.

2023 is the **60**th **Anniversary** of the founding of the Brainerd AAUW branch. Plans have been made to celebrate on March **11**, 2023. But Mother Nature intervened, and the celebration has been postponed to September **16**, 2023. The Branch History committee has been scouring the Crow Wing County Historical Center archives, members materials and have developed a branch history booklet.

The successful **Brain Buster Trivia Challenge** was held on January 21, 2023. Rebecca Timmins is the new Quiz Master. The questions were difficult. There was one "perfect" round by one team. That is a first-

time occurrence. The event raised funds to provide scholarships to Central Lakes College students through the CLC Foundation. Comments were "this was the BEST trivia challenge ever"!

AAUW Duluth

The Duluth Branch had our Summer Social in September and announced that we had 3 scholarship winners this year. In October we toured the Fond du Lac Tribal and Community College, its art, and architectural features. Our November Program, "Our Common Call to Hospitality-Welcoming Afghan Newcomers," told the process of the Peace Welcome Circle and two young Afghan women shared their moving stories of escaping Afghanistan and relocating to Duluth. Our Winter Social in December was filled with music, our speaker shared his story and LGBTQ culture, and donations were collected and delivered to Safe Haven women's shelter.

In February. we continued, "The Daughters Series" over Zoom and Sarah Bosch (daughter of branch member, Nancy Aldridge) spoke about her joy to be the Science Specialist at Horace Mann Elementary in St. Paul and how she works to bring racial equity to her classroom. On International Women's Day, Jackie Falk, our Duluth Branch Public Policy Liaison, provided us with the history of ERA legislation and ways to help push it over the finish line. Our Annual Meeting is scheduled for May at the beautiful Kitchi Gammi Club with speaker, Dr. Melissa Walls, Director of the Center for Indigenous Health's Great Lakes Hub.

We co-sponsored three events with local partners: the Twin Ports Trafficking Awareness Month Opening Ceremony in January; "Fannie Lou Hamer: Stand-Up," a documentary film about the civil rights leader, and its discussion in February; and in March a presentation about the National Popular Vote by Eileen Reavey, National Grassroots Director for National Popular Vote.

AAUW Ely

During the 2022-2023 AAUW year, our branch has provided several presentations that were wellattended by the Ely community as part of a multi-year educational project called Awareness...Then Change. This initiative, launched in 2021, is designed to increase understanding, honor the heritage of the area, and set the stage for supporting policy and social action to reduce risk and support the resilience of Indigenous women and children. In September, the branch hosted "Unhappy Hour" for the community at a local coffee house/bar to educate the public about the pay inequities of our BIPOC sisters with particular focus on Indigenous women. In October, the branch invited a coordinator from PAVSA (Program for Aid to Victims of Sexual Assault) to discuss current issues facing the Native American population and ways we can become allies and help build safer, more responsive systems for all. In November, a grassroots organizer from the Bois Forte Band of Chippewa spoke about local economy building for Indigenous populations and the food sovereignty movement. In February, we hosted a pizza luncheon for about 125 students that attended a day of Indigenous-focused films as part of the four-day End-of-the-Road Film Festival at our local theater. In March, the branch held a community event focusing on the Treaty of 1854 and the impact on Indigenous healthcare as presented by a physician (and Ely AAUW Board Member). Ely EMPOWER (a local advocacy group for women in the Ely community) contributed a portion of the funding for the "Awareness...Then Change" initiative.

Last summer, our branch hosted two community events with big turnouts celebrating the 50th anniversary of Title IX. The first event was a presentation with two impressive speakers – an Olympic gold medal winner from the 1988 U.S. wheelchair basketball team and a starter on the U.S. Junior Pan American Gold Metal team and all-time leading scorer at the U of Iowa. The second event was an

inspirational presentation highlighting the positive impact Title IX has had on 15 Ely area women – young and old – sharing their stories.

The branch, jointly with Ely Empower, sponsored three girls at a four-day Engineering Camp at Itasca Community College last summer. In the fall, a scholarship was provided to a female student at Minnesota North College. In February, scholarships were awarded to two sophomores for the five-day Camp Atsokan Writing Camp next summer. Every spring (except during Covid), the branch holds a STEM Workshop for girls in Grades 5-8. We plan to send a young college woman to NCCWSL this June.

Our auctions and raffles during our Garden Party in July, the Holiday Celebration in December, and the End-of-Year Banquet in May as well as member donations go a long way in funding our scholarships and programs. We believe most of our membership increase since February 2022 is due to interest in our mission-based programs and visibility in the community because of our events. And we are thrilled that about 30 percent of the new members are under the age of 35.

AAUW Faribault

Since meeting two years on Zoom, our group has returned to meeting again in person. In October we sponsor a get to know your Candidate Form for elections of our local government and State Senate and Representative, allowing the public a question answer program.

Hosting a large Halloween Breakfast is a big fund raiser for our scholarship program. In the Spring we also have a Book Sale fundraiser. Local support of both events is well received.

Our Book Club group is also very active discussing many great books as well as taking tours to bookstores and a play on a book reading.

For Women of the Month, our group writes articles on women in history or local women which are published in our local newspaper. Our monthly meetings are planned with interesting speakers with women who are in business or politics.

Getting together socially is very important for our group holding monthly coffees and dinner for groups of birthdays. Planning a social meeting time for the group to take part in meditation, relaxation or a craft is also important to us.

AAUW Fergus Falls

The Fergus Falls AAUW branch hosted their Holiday Tour of Homes fundraiser on November 5th, 2022. Six Fergus Falls homeowners opened their beautifully decorated homes for the public to experience holiday décor ahead of the season. They included a Habitat for Humanity home, two historic homes (one on the 100-year registry and one 150 years matching our Fergus Falls' sesquicentennial), a Shouse (Shed house), and a home with a wood shop to appeal to both men and women. 15 area businesses donated their décor or other goods to make the event a success.

Branch members participated in the event by volunteering, promoting, purchasing tickets, coordinating, baking, and giving financial support. We sold 575 tickets which raised more than \$12,000 towards scholarships for women.

Event chair Karen Nitzkorski says, "It's our only fundraiser which we use to provide scholarships for women to attend institutions of higher education. It's so rewarding to be able to award scholarships to

amazing women. The essays from the women who apply showcase a depth of character and resiliency giving hope for our future."

AAUW Grand Rapids

First, we have a program at each of our regular meetings. One of the favorites was the program: Reflections from the Polish-Ukrainian Border: Impacts on Women started off the fall with Presenter, Bernadine Joselyn, Former Diplomat at the U.S. Embassy in Russia. Her presentation titled, Reflections from the Polish-Ukrainian Border: Impacts on Women gave us insight about the plight of women from her recent travels to the Polish-Ukraine border to assist war evacuees.

Second, one of our fundraising efforts was to fund two camperships for one middle school girl and one high school girl to attend the Minnesota North College – Itasca Summer Engineering Camp (STEM). Our members also donated supplies and funds for snacks to support the STEM effort.

AAUW Hastings

Here are a couple highlights from what has been a really great year in Hastings. We have grown our membership to more than 100, increased the number and type of scholarships being given by the branch and achieved some really great fundraising and fellowship.

- Two Summer Fundraising/Fellowship/Membership events were an amazing success -
 - First, AAUW Hastings hosted a used book sale tent at the Hastings Rivertown Days Arts and Crafts Fair in July 2022. We were able to have members work together before, during and after the sale to build fellowship within the Branch. The booth was prime visibility for AAUW Hastings Branch during the two days of our community's summer celebration. Gross sales exceeded \$700 allowing our branch to cover event costs, increase our support of Hastings Reads (an annual community "one-book" event in February), and contribute to our Branches high school scholarships.
 - Second, AAUW Hastings hosted our second Wine Soiree in August 2022. This was done as our branch's primary fundraiser (7 raffle items), Share the Future membership event, and program year kickoff event. In all categories expectations were exceeded. Over \$5,000 was raised for high school and NCCWSL scholarships, the event was a primary driver for moving our membership to over 100 from 87 the previous year (6 Shape the Future Members joined at this event), and attendance at our programs all of 2022-23 has been higher than previous years.
- AAUW Hastings reconsidered our high school scholarship program. For many years we have been providing a \$2,500 scholarship to a Hastings HS female graduate with high academic achievement. Upon reconsideration by a committee of interested members, it was decided to offer two scholarships to the 2023 graduating class, the first of \$2,000 using previous selection criteria and second of \$1,000 to a Hastings female graduate who is entering a trade or 2-year college program supporting vocational training in a male dominated field. We are excited to assess the success of this scholarship switch over the next few years.
- AAUW hosted a joint program with the Hastings High School Feminism Club with representatives of the MN Federal Reserve discussing equity regarding women's wages and economic value, specifically through COVID. This was a program funded with AAUW MN's Strategic Plan Program Grant.

AAUW Hibbing

The Hibbing branch has had another wonderful year. Our biggest event each year is our famous annual book sale. Last year we held our first sale since the start of the pandemic, and it was a record-breaking year for sales. We were able to give out larger scholarships to all applicants. The sale had typically been held in early February, but due to scheduling conflicts with our building, we had to move it later in the spring. Patrons definitely seemed to enjoy the better weather for venturing up here (some coming from the cities and even farther), so we decided to keep holding it in the spring. We are actively preparing for the 2023 sale coming up in May.

Throughout the rest of the year, we enjoy exceptional programs. We recently welcomed a presentation from a former Future Collegian whom we helped send to Washington DC to complete research for her master's project. We've also welcomed area medical professionals and a sign language specialist, and we will get to meet a local police canine who specializes in electronics detection. In addition to our wonderful programs, we are also continuing our bus trips to see plays in Duluth.

AAUW Metro West

We are operating this year with a reduced number of officers, so our activities have been focused on monthly programs as well as an active book club. It has been great to be able to meet in person again, after meeting by Zoom during the pandemic. We are trying something new this year: most of our meetings have been luncheons at the Gold Nugget Restaurant in Minnetonka. We order from the menu, then enjoy a program followed by a short business meeting. We have had a variety of interesting and educational speakers, including Hopkins School Board member Katie Pederson; Cheryl Engelbretson, culinary nutrition expert, personal chef, and health & wellness coach; Dr. Alisa Tomette, founder of Wholistic Health U., provider of health programs for seniors; and Kelly Hinnenkamp, Annandale City Administrator.

AAUW Minneapolis

It has been a year of change for the Minneapolis Branch of AAUW. After over 70 years of owning the Gale Mansion and starting and operating the Gale Business, we decided to sell both. The Covid 19 pandemic made running an event business very challenging. Having a house that was 111 years old and in need of constant repairs was also difficult. Our branch decided it was time to focus on being an organization rather than a house and a business. Surprisingly we received offers fairly quickly. On October 14, 2022 we sold our house and business. We are now renters instead of owners and continue to meet in the Gale Mansion. We are in the process of developing a new strategic plan and deciding how we will move forward to meet the AAUW mission of equality for women and girls.

In the process of getting ready to sell the house, we have found a treasure trove of historical pictures and articles. We recently received a grant from the Minnesota Historical Society to complete an oral history of the Minneapolis Branch. So far two of our members have been interviewed. Four or more are soon to share their knowledge of our branch. When this is complete, we hope to apply for another grant to digitalize our archives. The Hennepin County Library has agreed to store our historical documents.

We continue to have 3 programs every Monday. The programs this year have been outstanding. It would be difficult to choose just one or even two to write about. The next program seems to be better than the last one. Each Monday we meet in person and on Zoom for those members who cannot attend or who are out of town. We have had speakers from other states and countries who speak to us on

AAUW Owatonna

The Owatonna branch kicks off every fall with our annual fundraiser, **The Taste of Steele County**. We learned more about diversity, equity, and inclusion from The Alliance for Greater Equity organization in Owatonna. In February, a St. Olaf professor presented her program titled Sacred Waters. She discussed water's generative and destructive capacities and how water has long intrigued human societies. Attendees learned how we can all be more aware of our relationship with our regional watershed and the struggles of water disparities worldwide.

AAUW Red Wing Area

On August 7th, 2022, we featured a public celebration of the 50th Year of the passage of Title IX in our River City Days Parade. We sponsored a large float pulled by a pickup. On the float we had an enthusiastic group of young Girl Scouts (Brownies) tossing a basketball back and forth and into the basketball hoop. The girls were working on their Sisterhood badge or a Good Citizen badge. Other sports paraphilia strewed about the whole float – complete with balloons and flyers featuring the contribution of Title IX to girls in sports and academia. This event gave visibility to our local AAUW branch. Several members marched alongside the float passing out AAUW information on membership, upcoming events and of course candy to onlookers.

Perhaps our most notable endeavor this year was our Literacy Program. Thanks to the grant received from AAUW-MN we created an ongoing program promoting 3rd grade literacy through efforts to improve their learning environments. The purpose: To support and encourage 3rd grade students when they take the Minnesota Comprehensive Assessment (MCA) test for the first time in reading and literacy. We collaborated with teachers, the RW Public Library, United Way, local businesses and parents as partners. Our members sewed roughly 190 bags. The bags contained a parent information sheet about the importance of good nutrition/sleep, a short story with practice bubble test, #2 pencil, a bookmark to color, library application, coloring sheet about local native plants, (3) colors, a fidget toy, a healthy snack and a peppermint.

We advertised the program in the local paper, school and through our outreach events monthly. Each year we will re-evaluate the program's success and determine how to further improve our programming. Education is a cornerstone for AAUW. A collective effort to improve literacy in communities with parents/students is huge! Students need to know we support and care about them! We, believe this program could be a model for other communities.

AAUW Rochester

This year we were excited to be able to meet in person for our general meetings. We have seven general meetings during the year, including two dinner meetings and one luncheon. At our luncheon meeting this year our silent auction raised funds to support sending our NCCWSL student to the conference in May. Our general meetings are held in the evening at various Rochester locations. Topics we have heard about this year include collaborative programs at our community college which allows high school students to receive college credit while attending high school, a detailed description of the voting process in Olmsted County, a local singer/songwriter performing her original songs, author Virginia Wright Peterson discussing her latest book on the history of Rochester, and a high school senior describing her research into breast cancer.

Most of our board meetings are held via Zoom for convenience of our members and to avoid having to get out on the dark, cold winter evenings.

Our branch supports six book clubs, which attract new members, and a long-standing Foreign Policy discussion group which selects topics from the Great Decisions book.

Through the efforts of our Membership officers, we have been able to maintain a steady number of members and recognize many of our members who have become Honorary Life members (50+ years).


