MESSAGE FROM OUR CO-PRESIDENTS ANDREA AND LINDA

Greetings AAUW Ely Branch Members,

Voting is important, right? Our branch members, together with all AAUW members nationwide, will have an exciting opportunity to vote on a bylaw amendment to allow anyone who believes in equity for women and girls to become a member of AAUW whether they have a degree or not. Voting will take place online from April 3 to May 15. This vote needs to pass.

AAUW membership should not be limited to those with a degree. Those without degrees fight for gender equity just as we do. We can be stronger advocates when we are inclusive, not exclusive. Opening up membership to those without a degree will not change who we are and what we are working towards; it will strengthen our efforts by including anyone who is as committed as we are about equity for women and girls.

AAUW was founded in 1881 to encourage more women to pursue higher education and help to open the doors for career advancement. Very few women attended a college or university back then. AAUW evolved and began the fight for pay equity. The focus expanded to include advocating for the needs of people of color and communities in poverty. AAUW earned permanent United Nations observer status in 1946 which led to AAUW members expanding the fight for civil rights. In the 143 years since our founding, AAUW never stopped advocating for education while expanding our focus to issues impacting women in addition to pay equity – maternity leave, sexual harassment, violence against women, reproductive rights, and so much more.

This bylaw amendment requires a two-thirds majority (66.67%) of those voting to pass. When this amendment was last voted upon in 2021, it just missed passing with 63% voting for the change. Let's get it passed this time!

Voting will be online starting April 3. AAUW uses Simply Voting, an independent voting system. Members will receive emails from vote@simplyvoting.com with their own unique Elector ID and Password to vote. Add vote@simplyvoting.com to your contacts. It is not spam.

This is a bylaw change that needs to happen. Let's change the bylaws to allow anyone who supports AAUW's purpose of advancing equity for women and girls to be a member. Please vote.

Join us for the next branch meeting on March 12 at the Grand Ely Lodge. Our speaker, Kelly Klun from Klun Law Firm (and AAUW member!), will discuss estate planning.

Come early at 5:00 for social time. The program starts at 5:30 followed by our branch meeting. Hope to see you there!

ERA MN RALLY

On Monday, February 12, 2024, eight Ely Branch members, along with Jan Carey, AAUW MN State President, attended the opening day of the legislative session. We gathered in the Capitol Rotunda for a high-energy rally from 10 am to noon. The intent was to send a message to all our State Representatives and Senators to pass a bill in both chambers to include the Equal Rights Amendment on the ballot and let the citizens vote for its inclusion in the Minnesota State Constitution.

In our bright green ERA YES t-shirts, we gathered with a large contingent of AAUW members from all around the state and many others advocating for equality for all. The morning began with group chants and singing, bringing high energy and passion to the historic space.

The inspirational speakers included Senator Mary Kunesh and Representative Kaohly Her, (co-sponsors of the bill), Attorney General Keith Ellison, AAUW Vice President Public Policy Chair Kelsey Waits, and many others. It was heartwarming to hear so many diverse voices speaking up for the passage of the amendment. It was clear that those who stand for the ERA also stand for the rights of all marginalized people.

My hope is that the next time we travel to St. Paul for an ERA rally, it will be to celebrate the achievement of the Equal Rights Amendment being added to the State Constitution, making Minnesota the most friendly state in the US for women, girls, and, in fact everyone, to live in.

2024 PROPOSED Robust Language for SF 37:

All persons shall be guaranteed equal rights under the laws of this state. The state shall not discriminate against any person in intent or effect on account of race, color, national origin, ancestry, disability or sex, including but not limited to pregnancy, pregnancy outcomes and reproductive freedom, gender identity, gender expression or sexual orientation.

The luncheon, at the Senior Center, was catered by Gators with the cost covered by Ely AAUW and Ely EMPOWER.












PUBLIC POLICY AAUW Ely, Public Policy Committee by Mary Setterholm



Public Policy initiative for Quarter 1, 2024

As a follow up to the Tuesday Group presentation AAUW sponsored discussing Human Trafficking, we will be providing the above posters for

area businesses to display in bathrooms. These posters will provide a resource for individuals being trafficked.

Minnesota law requires all lodging employees receive initial and annual training that focuses on the accurate and prompt identification and reporting of, or response to, suspected sex trafficking. In addition to this training, the law requires that each establishment develop a protocol establishing the process for reporting and handling suspected sex trafficking.

Public Policy members met with Chad Houde, Ely Police Chief to explain our project. He was very supportive. Members of the Public Policy committee will meet with the Chamber of Commerce to make them aware of our activity and encourage them to let their membership know posters are available.

Public Policy teams of two will contact bars, restaurants, hotels, gas stations, and Minnesota North Vermillion campus and encourage display of the poster in their bathrooms.
