Communications issues are prevalent everywhere. AAUW MN provides every tool to communicate through the website, FB page, THE PINE, email postings, postcards, newspapers and phone calls. But we can't make members read, open email or the website or follow on FB. Please try to be cognizant to all the tools being used to keep members informed.

Promotion of public policy priorities at the branch level is going to be critical as we move closer to November 5, 2024. I can only say 'women must prevail'. Convince every person, every gender, every ethnicity of the importance of their vote in national and state elections. Our lives literally depend on it.

Moving Forward ~ Collectively Advocating

NCCWSL 2024



Eleven students from Minnesota attended the 2024 AAUW National Conference for College Women Student Leaders (NCCWSL) at The University of Maryland. AAUW Minnesota provided nine \$1000 grants to the following branches to assist with their sponsorship of a college student: Brainerd Area, Ely, Duluth, Hastings, Minneapolis, Owatonna, Red Wing Area, Rochester, and Willmar. Students were given the option of attending 40 workshops and Panel Discussions including sessions *Authentic Leadership: Meaning, Impact, and Challenges for Emerging Leaders,* How to Amp Up Your Political and Civic Engagement, Leading from the Heart: The Basics of Nonviolent Communication, Exploring Quantum Computing and Machine Learning: Building Blocks for Future Innovators, and This Woman's Worth: Communicating Your Personal Brand. The success of the Conference can best be communicated in the words of a few of the Minnesota students attending NCCWSL:

Haley Patel, UMD Student sponsored by the Duluth Branch, wrote During the AAUW NCCWSL 2024 I was able to retain so much knowledge from the informational workshops that were offered. One of the workshops that stuck out to me the most was "Eliminating the Leadership Gap". This workshop was a leadership panel of women discussing the challenges they have faced in their respective fields and ways to overcome them. Some advice that they gave that really resonated with me are the following. One piece of advice was to "Always take a seat at the table", they discussed the barriers you may face with finding support in the workplace and ways to find allies to help you get a seat at the table to in a way, asset yourself. Another piece of advice that really spoke to me was to "Inhale confidence, exhale doubt". During this part of the panel, the panelists explained the importance of confidence and why you should show up in spaces like you belong in them. They explained that if you were invited into a space, you belong there, so own it. There were many other workshops that I had attended, two more of those "Financial Literacy, Smart Budget, Finances and Future" and "Designing Your Post Grad Career" helped me gain tools to grow personally and professionally.

I made the most of this conference and I was also able to network and develop new friendships with the women student leaders at this conference. Overall, AAUW NCCWSL 2024 gave me the opportunity to understand more about ways to develop my leadership, professionalism, and activism skills which is going to be able to help me better serve as an outlet for the multicultural and marginalized communities at UMD."

Minnesota AAUW Funds

The Minnesota annual convention held in Hastings on April 26-27, 2024, included a silent auction for AAUW Funds.

There were 36 items that were donated for the silent auction. Payments were made via checks, cash, and credit cards. The final collection was \$2913 after the credit card transaction fee deduction. The Minnesota AAUW funds contribution amount for 2023, based on the December 2023 report received from National AAUW, was \$89,630.49

The majority of the donations were made towards supporting the 9110-AAUW Greatest Needs Fund. The other funds supported by MN AAUW are: 4450-Education & Training Fund, 4449-Economic Security Fund, 2504-National Conference for College Women Student Leaders Scholarships, and 4452-Leadership Fund.

National Open Membership Election Results.

A bylaws change requires an affirmative vote by 2/3 (66.6%) of the AAUW members. The affirmative vote for opening membership to those who do not have a college degree was 65.1% of members. In Minnesota 72% of members voted for open membership. However, of the 1,534 MN members eligible to vote, only 651 voted. Of those 174 voted no and 441 vote yes.

2024 State Annual Meeting

The Business Meeting

One hundred twenty-one members and guests attended. There were eighty eligible voters consisting of seventy Branch delegates, four Past State Presidents and six State Board Members.

The budget proposed by the Finance Committee and was adopted unanimously. The following officers were elected:

Offices remaining unfilled are Vice President for Membership and two additional members of the Nominations Committee.

Vice President for Public Policy Kelsey Waits presented the Public Policy and Biennial Action Priorities for 2024-2026, which were adopted unanimously.

The Resolution "Therefore, be it resolved that AAUW Minnesota vigorously supports passing the ERA to the Minnesota Constitution." Proposed by AAUW Duluth Branch was unanimously adopted. No resolutions were offered from the floor.

The State Meeting Booklet includes details. On its cover is a beautiful illustration of Hastings by award winning local artist, Andy Evansen.

The Program

The Program based on the theme **Confluence = Inclusion, Collaboration, and**



Empowerment began Friday evening with **Britta Johnson**, Hastings Branch Scholarship Recipient and NCCWSL student, who now works as a legal assistant at Davis and Goldfarb, an immigration law firm in Minneapolis. She spoke about how AAUW's support helped guide her to her current career.

She was followed by **Suzan Willhite**, ERAMN President Emeritus and Member of Woman Corp., who spoke regarding the status of the Equal Rights Amendment in Minnesota.





The Friday Evening Keynote Speaker, **Megan Peterson**, Executive Director, Gender Justice, spoke about Gender Justice's success repealing Minnesota abortion restrictions, protecting the rights of transgender kids to learn in safe environments and get the health care they need and ending state funding of anti-abortion crisis pregnancy centers. She emphasized the need for a state constitutional amendment to protect these achievements. Laws can be overturned in the

next session of the legislature or interpreted too narrowly by courts. Only constitutionally protected equal rights as set forth in the proposed Minnesota ERA Constitutional Amendment can secure these vital frights.

On Saturday **Lisa Hedin**, Hasting Branch President and Hastings **Mayor Mary Fasbender** welcomed AAUW MN to Hastings and Senator Amy Klobuchar joined us by video.



The Keynote address followed the business meeting. Dr. Karen Kedrowski, Professor of



Political Science at Iowa State University and Director of the Carrie Chapman Catt Center for Women and Politics, gave a presentation on Gender Wage Gap. Her rationale for the gender wage gap is based on the following factors: 1- occupational segregation (women's jobs vs men's jobs), 2- deviations women have from the typical male work pattern (women more likely to work part-time, change jobs, work for the government)

3- more deviations (men negotiate aggressively, selfpromote, are in a union job) 4- plain old discrimination (get

paid less for the same job, e.g. Lily Ledbetter, women's national soccer team). The Wage gap has a lifetime earnings loss and lifetime retirement loss for women. This is not just a women's issue it affects family income and family legacy earnings. There are public policy and private actions by employers and employees that can be taken to reduce the wage gap. This does not have to continue. We in the USA are behind most other industrialized countries in terms of support for women rights.



<u>Michelle Witte</u>, Executive Director of the League of Women Voters of Minnesota, spoke of the importance of encouraging voter registration on college campuses and in high schools through non-partisan efforts. Students are more apt to vote if they are already registered.

Lt Governor Peggy Flanagan told us about three generations of women in her family

who have worked for equity and how important that legacy is to her and for her daughter.

Hastings Women Entrepreneurs. The final program at



the Annual meeting was a panel of Hastings women entrepreneurs. Moderator, <u>Jan Hertel</u> posed questions to owners <u>Jen Fox</u>, Spiral Microbrewery; <u>Nicole Sindelar</u>, Hastings Golf Club; <u>Barb Hollenbeck</u>,

Second Childhood Toy Store; <u>Sara Lawrence</u>, Muse 2320 Fiber Company; and <u>Dr.</u> <u>Rachel Allgor</u>, Journey Audiology and Hearing Care. The panelists answered questions such as: What is your greatest challenge as a business owner? Is your status ever questioned? What are the pros and cons of being your own boss? What motivates you to keep going? Who has been your role model? How many hours per week do you typically work? How did you get through Covid? For the question "Describe personality traits that are necessary to be a successful entrepreneur?" Some answers were: humility, gusto, sense of humor and patience, perseverance and perspective, growth mindset, and confidence in yourself. To the question "What do you wish someone had told you?", a panelist responded: "I wish I had had leadership training". Members in the audience were encouraged to ask questions of the panelists also. This panel discussion was an interesting and fast paced successful ending to the 2024 AAUW of Minnesota Annual Meeting.

June 13, 2024 State Board Meeting (ZOOM)

<u>President Jan Carey</u> reported on her activities with national committees. She emphasized the need for a State Diversity Officer and for a College/University Representative. She will be providing a comprehensive statement of achievements and aspirations to branch president.

Janice Quist, Finance Chair raised the ongoing need to pay operational expenses from savings and recommended that the Board consider proposing an increase in state dues. She suggested a \$3 increase, which would make the state dues \$12. This would not eliminate the need to withdraw from savings, but would significantly reduce it. Such a change would require approval at the 2025 State Meeting.

<u>Teresa Sagen, Administrative Assistant</u> is preparing the 2024-2025 AAUW MN State Directory. Branch presidents should provide information for the Directory as soon as possible. She also reported that the website has been edited in order to make room for new material.

Rajani Sohni, Vice President for AAUW Funds submitted the report reprinted above in this edition of The Pine.

<u>Karen Kirkwood, Vice President Program</u> plans to urge branches to start early to prepare applications for Strategic Plan Grants. She will encourage them to go beyond having speakers, to use panels discussions and they can also use National's Plug and Play Programing.

<u>Kelsey Waits, Vice President for Public Policy</u> plans to work with other like minded organizations to pursue AAUW public policy goals, including getting ERA on the Minnesota ballot in 2026. She also hopes to establish a virtual branch.

Pat Powers, Vice President for Membership raised whether the Board should apply for a Melinda Gates Foundation grant. Perhaps for a project utilizing our advocacy partners or a MN CU 'conference' to further engage collegians with regard to the AAUW mission (e.g. voter issues with Michelle Witte Secretary of State Steve Simon; pay equity with Karen Kedrowski or Title IX. The 'conference' could include actual StartSmart/Work Smart training of the collegians on the spot as an activity. This idea will be pursued.

Annual State Meeting 2025

AAUW Austin Branch has offered to hold the 2025 State Meeting. It will likely be held in late April.
